## LEVY INFORMATION

OUR SCHOOLS RELY ON LOCAL SUPPORT TO FUND ESSENTIAL PROGRAMS

The Supplemental Levy of \$995,000 is a **REPLACEMENT** tax. As a tax payer, your taxes will be slightly **DECREASED** from last year if this levy is approved on **March 12, 2019**. This Supplemental Levy will allow the Troy School District to continue the current programs:

### IMPACT ON TROY SCHOOL DISTRICT TAXPAYERS
